Essex County Council (ECC) is a local authority that serves a population of over one million people within the non-metropolitan county of Essex in England, UK.

When they realized the limitations their on-prem architecture was placing on their operational capacity, ECC embarked on a program of work to migrate their IT systems from their existing data centre to a new hosted data centre.

Meeting a need for a swift and faultless migration

With contractually binding migration dates, they needed needed efficient, independent, and objectivetesting to de-risk the data migration.
